






## 21ST ANNUAL TRANS-ATLANTIC TRADE AND INVESTMENT SYMPOSIUM

## SPEAKERS BRIEF PROFILE



Khafra Kambon, Doctor of Humane Letters (h.c.), O.R.T.T. C.M. is a national figure in Trinidad and Tobago since 1970 when he was one of the leaders of the Black Power movement. He is Director of Regional and Pan African Affairs of the Emancipation Support Committee of Trinidad and Tobago after service as Chair of the Organisation for 28 years.

Professionally, Khafra Kambon is a UWI trained economist and retired Managing Director of Kaf Sha-Ra Services which provided services in the field of research, data analysis and Human Impact Assessments for major development projects.

He is the Regional Coordinator of the Caribbean Pan African Network (CPAN), an umbrella body of regional civil society organizations formed in 2004 and linked to the Diaspora Initiative of the African Union. CPAN has attained Associate Member status on the CARICOM Reparations Committee.

Kambon has been awarded the Chaconia medal silver for community service and the Distinguished Alumini Award of the UWI. Kambon is the author of numerous articles and the book For Bread Justice and Freedom: A Political Biography of George Weekes.



#### SENATOR THE HONOURABLE PAULA GOPEE-SCOON

### **GARTH THOMAS**



He is currently working with the GroundUp Project and other partners to raise a \$250 million SDG-SME Fund of Funds with support from Convergence, the global network for blended finance. He is a fellow of the Aspen Global Leadership Network.
